Noted: The meetings with the RWNGC have been ongoing throughout the year and are confidential and delicate at this stage. AGM has been held back hoping that a result could be announced. The committee are hoping to give further updates in the New Year.  
  
Relations with the NT have improved and SH&DCRA are looking forward to settled relations in the coming years.
4. Treasurer's Report: This was circulated to those present. The balance in the accounts is very low because of the amount of legal costs over the last few years. It is hoped that income will pick up over the next twelve months.
5. Reeves Reports:
  - Dog bins on the common at Overy Staithe. SH&DCRA committee representatives have met with representatives of Burnham Overy Parish Council at the site of the dog bins. BOPC have been asked to remove the dog bins from the common. A response from the council is now awaited.
  - An update on what seems to be the theft of Overy Marsh 77 acres and half of the island by Holkham Estate/Earl of Leicester aided and abetted by the Land Registry was given to the meeting. All efforts are being made to correct this including reporting the matter to the Norfolk police serious fraud team and further enquiries for information from the Land Registry.

Unfortunately, NCC will only recognise a single right where multiple names are on the right numbered in the register. SH&DCRA committee have been to County Hall a number of times looking into this and other matters. Secretary will look into this again with NCC.

The committee have continued to meet on a monthly basis in order to manage Association business. Protecting the commons from encroachment is an ongoing concern but all in all it has been a more positive year:

- The Royal West Norfolk Golf Club: SH&DCRA representatives are meeting with representatives of the RWNGC concerning compensation for tolerating loss of grazing over CL124. A survey was undertaken showing over 90% in favour of these discussions.
- The National Trust: Relations between the NT and SH&DCRA have improved somewhat this year. A new local manager – Peter Nicholson - has been put in place by the NT. The new more market rate mooring charges are now being fully implemented in Brancaster harbour and this will have an impact on improving the compensation paid to SH&DCRA for tolerating activities on the common.
- Burnham Overy Harbour Trust and Holkham Estate: the situation remains unchanged as both organisations have continued to ignore common rightholders and are carrying on with their unlawful activities on the common. SH&DCRA Committee are moving forward with their attempts to reach a lawful use of the common for all interested parties.
- National Trails: There has been much consultation with National Trails concerning the Brancaster boardwalk section and removal of cattle gates. The historic position put forward by the Committee regarding cattle gates was confirmed by the National Trails team and gates will be retained.
- Carbon capture and reed management: The committee have been in touch with the Broads Reed and Sedge Cutters Association and a survey has been undertaken. The committee also have the services of an expert in carbon capture legislation and grant provision looking at how best to maintain CL124.

The committee has received a generous donation during the year and committee members continue to try to maximise income, including investigating crowd funding for projects. Whilst the action to recover funds from Brancaster Parish Council had to be abandoned because of the prohibitive legal costs, it was heartening to see that promises of backing to the tune of a quarter of a million pounds were forthcoming.

It's important to remember that, whilst committee members give time and their costs of travel for free, there are other costs for such as legal advice, insurance and printing that need to be covered. Common rightholders in the past made donations to SH&DCRA at the AGM; it would help if this tradition could be resumed this year.
